# ANNOUNCEMENT \_MOTA ENGIL AGREEMENT

## **KEY POINTS**

- PROVISION OF SERVICES, INFRASTRUCTURE AND KEY FACILITIES IN MALAWI SIGNIFICANTLY BENEFITS CHILWA
- EXISTING AGREEMENT HAS BEEN EXTENDED FOR 2 YEARS
- AGREEMENT SERVICES TO BE EXPANDED FOLLOWING INITIAL DRILL PROGRAM

## **OVERVIEW**

Chilwa Minerals Limited (ASX: CHW) ("**Chilwa**" or the "**Company**") is pleased to announce that it has reached an agreement with Mota Engil Engenharia Construcao Africa S.A. which is part of Chilwa's major shareholder, the Mota Engil Group ("**Mota Engil**"), for the further provision of technical and associated services in Malawi ("**Agreement**"). The Agreement extends the current agreement that was entered into prior to Chilwa's listing on ASX in July 2023.

The Company is extremely pleased with the support already shown by Mota Engil, who has a long and successful track record of operating in Malawi. The services provided are expected to cost the Company significantly less than if sourced through third party suppliers.

#### Chilwa's Managing Director, Cadell Buss, commented:

"We are extremely pleased to be aligned with our major shareholder in our focus on the delineation and development of a large-scale mineral sands project in Malawi.

"Having the ability and flexibility to scale up and down operations as required is a significant benefit to the Company and we couldn't be more pleased with the willingness to help from Mota Engil."

#### **Agreement Details**

The Agreement has been extended to January 2026 and is able to be further extended by mutual agreement. Either party may terminate without cause on 3 months' notice.

The Agreement includes the provision of accommodation and office facilities in Malawi, technical and administrative support staff, 4WD and support vehicles and other infrastructure, including a large storage shed which will be utilised for storing samples.

The Company has separate agreements in place with subsidiaries of Mota Engil Mozambique for the provision of drilling services, including the current sonic drill rig and the planned diamond rig that will commence late February. The rates for the drilling services are provided at a significant discount to third party contracted rates.
